## **Technical requirements to the paper**

Both abstracts and the application for participation in the conference are provided in the electronic version of the MS Word file. The file must be named after the surname of the first author. For example: «Karpov Abstracts», «Karpov Application».

Abstracts should be up to **three full pages of A5** (148×210) format, all margins are 20 mm.

Font of the text: typeface – Times New Roman, size -10, line spacing -1 pt, indentation -1 cm.

All figures contained in the abstracts are made in graphic editors compatible with the text editor MS Word.

Formulas are created in the MS Equation formula editor.

Figures, tables and formulas are designed in accordance with DSTU 3008:2015. Each figure should be signed; the table should have a title. Figures and tables, if there are several, should be numbered in Arabic numerals and placed across the line from the main text. Tables are made only in portrait orientation. Explanations of figures and table names are centered.

For example:

Figure 1 – Stages of the introduction of innovative technologies (font 9, bold)

#### Table 1 – Indices...

(font 10, the word «Table» is light-face italic type, the name is bold, straight)

UDC, author's name(s), scientific degree, academic rank, university name, should be printed in the upper left corner of the page, thesis name - in capital letters in the centre, separated by one line from above and below; then the thesis text is single-spaced, without hyphens.

If it is necessary, the list of information sources is applied in the abstracts in order of reference in the text in accordance with the requirements of **DSTU 8302:2015**. Text references to sources should be given in brackets, *for example:* [1, p. 55] or [1; 2].
