Memorandum of Cooperation

Non-commercial joint-stock company "Kazakh National Agrarian Research University", represented by the Acting Chairman of the Board – Rector Tireuov Kanat Maratovich, acting on the basis of the Charter, and the State Biotechnology University, represented by the Acting Rector Kudryashov Andrii Igorovich, acting on the basis, of the Charter, named below "The Parties" conclude this Memorandum for the purpose of developing cooperation in the field of higher education and science.

Based on the principles of equality and mutual benefit, the Parties identified the following areas of mutual cooperation:

- exchange of scientific and technical information, educational and scientific and methodical literature, periodicals;
- organization of collaborative research, conferences, seminars, and other scientific events;
- inviting representatives of the teaching staff to give lectures and conduct practical classes, supervise the scientific works of doctoral students, exchange experience and information on educational and methodological work, curricula and programs;
- mutual internships of academic staff;
- work on joint research, educational and commercial projects, bilaterally and within international programs;
- publication of scientific, educational and methodical materials based on the results of collaboration;
- · mutual review of scientific and educational-methodological works;
- exchange of students, master's students, graduate students, doctoral students for study, internship and educational practice;
- assistance in the cooperation of youth public organizations and bodies of student self-government of the Parties;
- participation in olympiads, competitions among students, academic staff and employees of universities;
- development of joint scientific projects on the development of agriculture and biotechnology.

The development and implementation of specific activities and projects based on this Memorandum of Cooperation will be discussed separately between the faculties, schools or institutes carrying out specific activities and projects. Before starting any such activity or project, a special agreement will be drawn up and signed by both parties, which will specify all the terms and conditions. Each party

agrees to carry out certain activities and projects in accordance with the laws and regulations of their respective countries after full consultation and approval.

If joint research activities pursuant to this Memorandum result in any intellectual property potential, each party shall seek a fair and equitable settlement of ownership rights and other proprietary rights that may arise.

This Memorandum takes effect after its signing by both Parties and is valid for 5 (five) years. The memorandum can be revised no later than one year before its expiration. Continuation or amendments to the text of the Memorandum may be made upon written notification and mutual consent of both Parties.

This memorandum is drawn up in two copies in the English, Ukrainian and Russian languages, which have equal legal force, one copy for each of the Parties.

Each party appoints a person who will serve as a liaison for the implementation of this agreement.
