



MEMORANDUM OF COLLABORATION

between

Wherein University of Applied Sciences in Nysa, Poland, represented by Rector, Dr. inż. Przemysław Malinowski, and Kharkiv Petro Vasylenko National Technical University of Agriculture Ukraine, Ukraine, represented by Rector, Prof. Oleksandr Nanka, recognize the need for and benefits of increased cooperation and communication within the international community of universities, and:

Wherein both parties agree that it is desirable to establish between them a relationship which will encourage such cooperation and communication, and wherein both parties desire to ensure that such a relationship will be mutually beneficial.

IT IS HEREBY AGREED as follows:

1. Both parties shall encourage the following activities to expand and promote their mutual interests:
 - a. Development of collaborative researches, joint participation in international academic programs, fulfillment of joint research projects in frames of international grants.
 - b. Exchange of faculty members and scientists, academic exchange of scientists and teaching staff with the aim of training, conducting lectures, participation in scientific conferences, workshops, seminars and academic meetings.
 - c. Development of joint educational programs, cooperation in arrangement of exchange programs for students and post-graduates with the purpose of training, research, language and industrial practice.
 - d. Exchange of academic publications and information, organization of joint conferences and seminars on agreed subjects, exchange of scientific information, providing opportunity for Universities staff to publish scientific articles as well as the results of joint scientific and research activities in specialized editions and scientific publications of Universities.



2. Both parties agree that prior to the invitation of any particular exchange and any other activity encompassed by this agreement, all financial arrangements with regard to that particular exchange and collaborative activity shall be settled in detail.
3. This agreement shall come into effect upon the signature of the designated signatories of both institutions, and will be automatically renewed every three years unless notice is given by either party to terminate the agreement.
