This agreement was signed between Utena University of Applied Sciences, hereby represented by Dr. Raimundas Čepukas, Rector, acting in confirmity with the Statute of Utena University of Applied Sciences, on the one hand, and State Biotechnological University, hereby represented by Andrii Kudryashov, in capacity of acting rector, acting in confirmity with the Statute of the State Biotechnological University, acting on the law whereby it is agreed as follows:

I. SUBJECT OF AGREEMENT

- 1. The purpose of this agreement is to agree to establish an international cooperation in the areas of study, joint degree programmes, system of study quality evaluation, teaching, tailored applied researches, implementation of projects and other areas.
- 2. This Agreement of international cooperation is approved in accordance with the legal arrangements of the parties and will be valid from the date of signature. The Agreement will last for 5 years, and will be renewed with the express written agreement of both parties.

II. ADMINISTRATING OF AGREEMENT

- 10. The exchange of members of technical or administrative staff when considered to be a profitable experience.
- 11. The cooperation and facilitation of publishing the scientific products (articles, research, methodical material, etc.) of their academic members in the professional journals of the other side
