It is necessary to send an application for participation in the conference (form attached), an electronic version of the abstracts in \*.doc, \*.docx format to the e-mail of the sections by **November 2, 2025**. Confirmation of receipt of materials will be sent to the authors in 24 hours. In case of non-receipt of the message, please repeat the sending.

**Participation in the conference is free**, the collection of conference materials in **.pdf** format will be sent to the authors by e-mail.

#### REQUIREMENTS FOR THE PREPARATION OF ABSTRACTS

Materials in the conference proceedings will be presented without editing, from the provided originals. Only scientific abstracts on the topic of the conference are accepted for publication. The volume of the abstracts should be 1-2 **full pages** of **A5 format**, made in Microsoft Word, font - Times New Roman, size - 10 pt, without text compaction and word hyphenation, line spacing - single, width alignment, indentation – 0.5 cm, margins on all sides - 2.0 cm. All diagrams, figures and tables must be titled and numbered. Titles of tables and illustrations are centered. Each table, figure, formula is separated by an interval of one line from the top and bottom of the main text. The figure is signed at the bottom, the table - at the top. Formulas are executed in the Microsoft Equation formula editor. For example: **Figure 1 - Structure** ...; *Table 1 - Indicators* ... (title - 10 bold, word "table" - 10 italic light).

The list of references should be given in accordance with the existing standard of bibliographic description (DSTU 8302:2015) or APA Style (of the American Psychological Association) at the end of the manuscript and should contain no more than 5 positions. References in the text to the source are indicated by the serial number in square brackets.

The title of the abstract is printed in large bold letters in the center. Indented line starting from the top right corner of the page, single spaced - the author's full name, academic degree, academic title; below - the name of the higher education institution, country. Surnames and initials of the author are highlighted in bold. The text of the abstract is printed after the indented line.

The Organizing Committee reserves the right to reject the material that does not correspond to the thematic areas of the conference, drawn up in violation of the above requirements. Authors are responsible for the accuracy of the facts, references, and copyright compliance.
